## **Fundraisers**

- Board delegated fundraisers under \$5,000 to the Finance Committee
- Krispy Cream Donut Life Skills at EHS \$2,000
- Fannie May Candy Band/Orchestra at EHS under \$5,000
- Both fundraisers approved by committee

## **Budget Update**

- Received \$5 million late from the federal government made fund balance look \$5 million lighter
- Received in July 2025
- One-time revenue masked \$5 million deficit
  - Was able to keep O&M and Education Fund out of the red
- The following accounts (funds) will be in red
  - o Transportation \$1.2 million in red overfunded fund balance last two years to be ready for this
    - Have two years to figure this out
  - Fund 60 Capital Projects
    - Fix things with money that have been saving
  - Health Life Safety
    - Bringing in \$500,000 and \$1.5 million available cash to do work with
    - Prior Board approved \$15-20 million in HLS work and have yet to go out and get the money
- Significant runway (3 4 years) to get behind whatever decisions the Board wants to address what needs to be reduced in costs still paying for a lot that was once covered by ESSER
- Fund Balance second highest it has been since 2019 in the Education Fund

# <u>Health Life Safety Bond Discussion – Kendall King with King Financial</u>

- Kings Financial is a Municipal Advisory firm based out of Monticello, IL
- Kendall King presented how bond process works a presentation was distributed to the committee

#### **KevGroup – Josh Waddle**

- Help modernize the payment process for DPS
- Software can integrate with Skyward and iVisions
- POS Device able to tap and pay or swipe and pay in lieu of cash payments
- Reports can be generated out of school cash to be provided to auditors during audit season
- Would be a convenience fee attached to the swipe
- One Year Agreement \$24,189 (includes a 30% discount)

## **Vehicle Discussion**

- Looking to replace 7 vehicles to increase efficiencies
- Of those 7 looking to replace only 4
- Chrysler Voyager looking to put into transportation fleet (teamsters)

- O State Bid \$40,678; Local Bid \$37,362; Lease \$39,950
- Lease is not paid up front
- Ford Transit Vans
  - O State \$49,467; Local \$47,348; Lease \$48,715
- F-250 / F-350
  - o Replace with maintenance vehicle
  - State bid \$74,668; Local bid \$74,458; Lease \$68,888
- Newer vehicles are needed
  - o Lease costs more, generally, in long term
  - Lease makes the most sense
- Will come to Board, in future, for vehicle replacements
