Ellsworth Dansby Jr. Magnet School Update (Brian Carper)

- Finishing concrete footings
- Will be done with areas A, B, and C by the end of this week
- Steel delivery set for Monday, November 13th
- Prepping for pre-cast
- Finishing site utilities
- Forming foundation walls wrap up this week and next week

Facilities Master Planning Update (Kent)

- Request for Qualification (RFQ)
 - o Released last week
 - Qualifications are due back on November 17th
 - o Purpose is to find someone to facilitate the whole process
- Member Clevenger mentioned AE Com, EY, and Deloitte
 - o Send to Dr. Clark or Melissa if more firms are known

Parking Lot Lease Update

- Need insurance paperwork from Logos Church (across the street form Muffley School) to take the lease recommendation to the Board
 - o Pay their insurance cost that went up due to leasing
- \$300/year annual lease payment and cost of seal and repairing cracks
 - o To be paid over 10 years

Construction Trades Trailer Update

- Invoices for repairs made to trailer
 - o Approximately \$4,000
- Discussion regarding providing building trades with new trailer look at from curriculum point of view
 - Talk to Ashley Grayned and Community Foundation about donations
 - o Talk to Building Trades about making contribution

Quarterly Education Fund Expenditure Report

- Document provided to committee
- Shows where district is at in the budget after the first quarter of FY24 in budgeted spending
- If committee members have questions let Dr. Curry

Modulars

- Currently have 3 modulars
 - \circ 2 6 classroom modulars
 - \circ 1 4 classroom modular
- Currently on a 12-month lease costing \$37,000/month or \$444,000/year
- \$1.6 million (each year) for 24-month lease option
- \$1.8 million for term for 36-month lease option
- Administration recommending 36-month option
- Dennis Mosaic
 - o Stairwell
 - o Initial Estimate from Christy Foltz restore stair tower \$1.1 million
 - Oshea between \$988,000 and \$1.207 million
 - o Time Frame wouldn't occupy until August of 2025
- Dennis Kaleidoscope to restore to stable condition not to where there are any other improvements to the building
 - o Initial estimate Autobaum \$2.5 million
 - Western Specialty Contractors \$2.38 million
 - Restore terracotta additional \$493,000
 - o Reoccupy in August of 2025
- 36-month recommendation will be taken to the board for consideration of approval on November 14, 2023

Tax Levy

- Everybody's assessment is up every county, homes, etc.
- Weekly snapshot from county clerk
 - o Ended last year at \$766 million − \$16 or more million that what we thought it was going to be − added multiplier to EAV of 1.068%
 - o Ballooned enough to catch almost all of it
 - o Last year did not go to truth in taxation hearing by staying under 5%
- This year alone EAV all by itself is up 9.83% as of November 6, 2023
- Current EAV is estimated at \$841,602,870
- Need to decide how to move forward
 - o If we don't levy what we can levy for, we will be leaving \$1.2 million on the table forever
 - o If we do levy what we can levy for (if nothing else changes) education fund would bring in \$21 million vs. \$20.6 million if we don't levy the full amount
 - o The only way to not get full amount is to lower tax rate in a particular fund
 - O Projecting a \$4.82 if we drop the tax rate to get just the 5% tax rate with bonds will be \$4.68 savings of 15 cents
 - o Estimation \$100,000 house will pay an additional \$140
- Dr Curry will prepare power point presentation for November 14th Board meeting
- Truth in taxation black box in paper anything over 5% no more than 14 days and no less than 7 days for December meeting
