Attorney Feeney noted that comments and/or scores (metrics) for the evaluation was Closed Session information, but the general process and timing were Open Session topics. Superintendent Clark replied that she will provide the necessary information for the Board of Education.</p> <p>President Clevenger noted that the Board of Education was on track to evaluate Dr. Clark in the month of February 2024. 	Dr. Collins-Brown asked about e-learning days versus snow days. Superintendent Clark replied that the Regional Office of Education approved the e-learning days to be utilized and not made up, however, students must have their active devices. Snow days have to be made up at the end of the year. Students were not taking their devices home and administration did not make sure technology was available. K-8 instruction was on our District's website. Administration was working on a plan that include devices and that does not include devices. They will also discuss with union leadership.	
	Mr. Scheider asked if there could be a permanent vacancy opening for certified librarians and the District would decide where he or she would be housed. He also wants teaching assistants in grades 3-5. These would help improve reading and math levels. There was no job fair this year because there was no full-time human resources director.	
	Vice President Dion asked about tuition reimbursements for teaching assistants. Deanne Hillman, Interim Director of HR, replied there is tuition reimbursement outlined in the TAs contract.	
	Mrs. Hillman noted that she would ask the recruitment and retention specialist to post the certified librarian position. There is an upcoming job fair scheduled on March 6 th ; more information forthcoming.	
Reports from Admins DLT and Their Departments	Executive Cabinet Members shared information regarding their departments, director reports and organizational charts (see attached). This presentation allowed the Board and others to know the areas of responsibilities and duties of each department. Along with who they oversee and their duties as well. There will be upcoming changes that would have a direct impact on student achievement.	Information only.
Stephen Decatur Facility Update	Kent Metzger, Director of Buildings and Grounds, shared information regarding the pipe burst at Stephen Decatur Middle School (SDMS) on Monday, January 15 th . There were thirty-seven classrooms and corridors effected by the water. Mr. Metzger thanked his crew for all of their hard work during this unfortunate situation. After the clean-up, air samples were conducted and they all came back negative. Students and staff returned to SDMS on Monday, January 22 nd .	Information only.

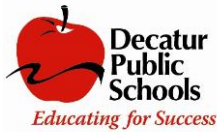

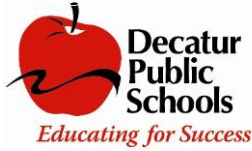

Their work identified five core competencies: self-awareness, self-management, social-awareness, relationship skills, and responsible decision making. I used these five competencies to design my program, Social and Emotional Learning: Royal Behaviors – The Making of Kings and Queens, to teach self-regulation to our children, enhance their self-esteem, and provide them with information that will help them develop positive self-images.



Dr. J. L. Simmons was awarded the title of Professor Emerita of Psychology at McKendree University (May 2022). She was the first tenured African American Professor at McKendree and has been a trailblazer in other areas within her discipline. She received her Doctor of Psychology degree in 1996 from Indiana State University, Terre Haute, IN which was entitled: *Adolescent Sexual Behaviors, Attitudes, and Knowledge: A Comparison of Teenage Parents and Their Nonparent Peers*. Dr. Simmons received her Bachelor of Arts degree in 1988 from McKendree College, Lebanon, IL, and her Associate of Arts degree in 1986 from Belleville Area College, Belleville,

IL. Also, she has received many honors and awards, to name a few: Technos International Week, Tokyo, Japan; Psi Chi National Honor Society in Psychology; Who's Who Among America's Teachers, Pi Gamma Mu International Honor Society in Social Sciences, Phi Kappa Phi Honor Society, Norman Grandy Faculty Award – Outstanding Professor of the Year, Chancellor of Northwestern Region of Pi Gamma Mu International Honor Society in Social Sciences, Member of Sigma Gamma Rho, Inc. - Alpha Upsilon Chapter of East. St. Louis, IL.; and several others. Currently, she is the C.E.O. of JLK Professional Development, LLC in Belleville, IL and is working with school districts in various cities the United States of America.

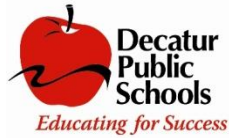

BACKGROUND INFORMATION:

Board Policy 3:50 – General School Administration – *Administrative Personnel Other Than the Superintendent*, guides Administration to make recommendations to the Board for salary adjustments annually during the March Board meeting. The Board and administration deferred recommendations until the conclusion of multiple union contract negotiations.

CURRENT CONSIDERATIONS:

The salary schedule recognizes a built-in step of 3/4% year-over-year. Administration is recommending a 2.50% increase to the base salary in each administrative position. The combined salary increase for administrators will be 3.25%. Administrative salaries will total approximately \$6,422,464.00. This total is approximate, as the district is still in search of a Director of Human Resources, an additional Director of Teaching and Learning, Decatur Learning Academy Principal, and three Assistant Principal Positions at EHS, Dennis, and Decatur Learning Academy.

FINANCIAL CONSIDERATIONS:

The administrator salary recommendation cost is approximately \$6,422,464.00.

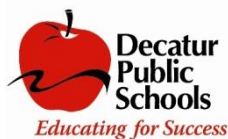

BACKGROUND INFORMATION:

Working Cash bonds were sold for the purpose of construction beginning with the BOLD Plan. This draw down of reserves clears the Working Cash Fund of revenue raised for construction as part of the BOLD Plan. To meet necessary construction bond timelines, the district intends to permanently abate \$175,000.00 from the Working Cash Fund to Capital Projects Fund.

CURRENT CONSIDERATIONS:

The District has no authority to expend funds from the Working Cash Fund. In order to make the funds available, the funds must be abated (transferred) from the Working Cash Fund (70) to the Capital Projects (60). **RESOLUTION AUTHORIZING THE
ABATEMENT OF WORKING CASH FUND**

WHEREAS, the Board of Education (the “Board”) of Decatur Public School District No. 61 (the “District”) has heretofore created and established a working cash fund in and for the District, pursuant to Article 20 of the Illinois School Code, 105 ILCS 5/20-1, *et seq.* (the “Fund”); and

WHEREAS, the Board is authorized by law to abate the Fund and direct the partial permanent transfer of moneys in that Fund to any fund or funds of the District most in need of the money, provided that the District maintains an amount to the credit of the Working Cash Fund, including taxes levied pursuant to Section 20-3 of the School Code and not yet collected and amounts transferred pursuant to Section 20-4 of the School Code and to be reimbursed to the Working Cash Fund, at least equal to 0.05% of the then current value, as equalized or assessed by the Department of Revenue, of the taxable property in the District; and

WHEREAS, the Board of Education hereby determines and finds that the Capital Projects Fund is the fund of the District most in need of the money; and

WHEREAS, the current balance of the Working Cash Fund, including any taxes levied but not yet collected, is Five Million Sixty-one Thousand Four Hundred Thirty-Six and .01/100 Dollars (\$5,061,436.01); and

WHEREAS, any moneys which have heretofore been transferred from the Working Cash Fund to another fund of the District pursuant to Section 20-4 of the School Code have been repaid to the Working Cash Fund in full; and

WHEREAS, an abatement of the Working Cash Fund and a transfer of One Hundred Seventy-Five Thousand Dollars (\$175,000.00) from that Fund to the Capital Projects Fund will

maintain an amount to the credit of the Working Cash Fund sufficient to meet the minimum requirement of the School Code; and

WHEREAS, the Board has determined and does hereby determine that it is necessary and in the best interests of the District that the Working Cash Fund be abated so that the sum of One Hundred Seventy-Five Thousand Dollars (\$175,000.00) be permanently transferred to the Capital Projects Fund;

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED by the Board of Education of Decatur Public School District No. 61 as follows:

Section 1. The Board hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does incorporate them into this Resolution by this reference.

Section 2. That the Working Cash Fund be abated effective February 13, 2024, so that the sum of One Hundred Seventy-Five Thousand Dollars (\$175,000.00) shall be permanently transferred to the Capital Projects Fund and may be used for such purposes as are allowable for the Capital Projects Fund.

Section 3. That, except as so abated, the Working Cash Fund shall continue to be used for the purposes for which it was created.

Section 4. That all resolutions or parts thereof in conflict herewith be and the same are hereby repealed and that this resolution shall be in effect forthwith upon its adoption.

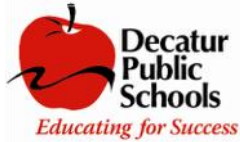

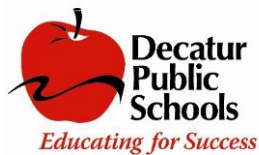

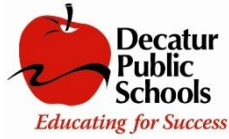

CURRENT CONSIDERATIONS:

Recently, the District accepted bids for two new MFSAB buses with a May delivery date. At that Board Meeting, the question was asked if the District could get any additional buses. Bids were sent out and will be opened on Tuesday, February 13, 2024 at 2:00 PM. Bid amounts will be presented to the Board at the February 13th meeting for acceptance or rejection. These activity buses hold 14 passengers and can be driven by a coach or sponsor with no additional requirements, other than a checkride with our Transportation Director Mrs. Kimmy Taylor. The buses will be utilized at both the high school and middle school level. These activity buses will be housed at the District Office and can be reserved by Middle School and High School Athletic Directors.
