BACKGROUND INFORMATION:

The Consolidated Election for the Board of Education was held this year on April 06, 2021. Outgoing candidates whose terms expired this year included four (4) members: Kendall Briscoe, Courtney Carson, Beth Creighton and Beth Nolan. Candidates whose names appeared on the ballot (in this order) for these four (4) positions included: Jason Wayne Dion, Krystal Johnson, Ferlaxnes Carson, Kevin Collins-Brown, Al Scheider, Alana Giselle Banks and Jayjuan Young. There were no incumbents that ran for re-election for 2021.

CURRENT CONSIDERATIONS:

On Thursday, April 22, 2021, Josh Tanner, County Clerk of Macon County, certified the Abstract of Votes as he canvassed the returns of the Consolidated Election held on Tuesday, April 06, 2021. This certification was emailed and received by Melissa Bradford, Board Secretary, on April 29, 2021.
