#### **BACKGROUND INFORMATION:**

Board Policy 3:50 – General School Administration – *Administrative Personnel Other Than the Superintendent*, guides Administration to make recommendations to the Board for salary adjustments annually during the <u>March</u> board meeting. Administration and the Board have been discussing administrative pay during closed session in preparation for this final recommendation.

#### **CURRENT CONSIDERATIONS:**

The Consumer Price Index (CPI-U), a factor designating inflation used in Illinios schools, for the year ending December 2020 was 1.4%. The salary schedule structure recognizes step experience as  $3/4^{\text{th}}$ %. The typical increase is approximately 2.16% (inflation plus step experience). All employees, with one exception are full time. There is one 0.75 FTE employee in Macon-Piatt.

Last year K-8 principals moved to a 240 day contract. Elementary principals are being moved from a 220 day contract to 240 days for the FY22 school year. K-8 assistant principals will move from 195 days to 200 days to be in-line with middle school assistant principals.

The Nurse Coordinator pay was updated to reflect a twelve month position moving forward as the current employee is on the retirement track and schedule to retire at the end of FY22.

#### FINANCIAL CONSIDERATIONS:

The overall cost for the administrator salary recommendation is \$7,024,106 including eight employes on the retirement track. The overall increase is \$226,459.50 or an increase of 3.33% over FY21. This increase accounts for building consolidations and the associated decrease in principals, as well as new assistant principal positions at some elementary schools.

The recommendation includes Macon-Piatt administrators; Macon-Piatt assumes the cost for their employees.

There are three positions not yet filled noted in blue: Director of Buildings and Grounds; Assistant Parsons; and the Dean of Students at MacArthur High School. The wages for these positions were estimated using Step 13.

The Board affords a stipend for any principal who has earned a doctorate. Currently, there are only two adminstrators who would receive this stipend. The recommendation is to increase the doctoral stipend from \$3,625 to \$3,750.

#### **BACKGROUND INFORMATION:**

Board Policy 3:50 – General School Administration – *Administrative Personnel Other Than the Superintendent*, guides Administration to make recommendations to the Board for salary adjustments annually during the <u>March</u> board meeting.

#### **CURRENT CONSIDERATIONS:**

The Consumer Price Index (CPI-U), a factor designating inflation used in Illinios schools, for the year ending December 2020 was 1.4%. On average employees are receiving a 2.16% increase.

The goal was to align the positions accordingly on the Administrative Support Salary Schedule. An additional technology position was added to support the efforts of Teaching and Learning.

There are six employees off schedule (highlighted in pink): three are beyond the 30 step schedule and provided 1.4% increases; three are high compared to the schedule and provided 1.4% increases; There are three positions (blue) that are To Be Determined, step five was used for estimating purposes.

#### FINANCIAL CONSIDERATIONS:

The overall cost for the administrator support salary recommendation is \$3,462,738.02. The overall increase is \$184,642.22 or an increase of 5.63% over FY21.

The Administration respectfully requests that the Board of Education approve the Salary Schedule and the respective list of Administrative Support Staff Wages amounts for FY2021-22 as presented.

For the summer of 2021, camp coordinators will be compensated at \$66.00 per hour for up to 200 hours district-wide, not each coordinator, to assist with planning and supporting the details of the program for April, May and June. The 200 hours shall be hours worked outside the employee's regular work day.

This agreement shall sunset at the end of the 2021 summer session. The parties understand that neither status quo nor past practice shall apply to prevent the sunset.

For any employee within four years of retirement for whom any portion of summer school pay would increase the employee's salary above the six percent (6%) cap (resulting in penalties for the District), such payment that exceeds six percent (6%) shall be paid post retirement so as not to incur penalties.

This language shall apply to all Decatur Education Association bargaining unit members.

### **BACKGROUND INFORMATION:**

Lead 180 will continue to work with Decatur Public Schools and support the efforts to improve the curriculum alignment, instruction and students' tasks. This partnership has provided ongoing learning in regard to aligning instruction and learning to the rigor of College and Career Ready Standards. The district began this partnership during the 2020-2021 school year to ensure technical assistance and support was provided to teachers aligned to the areas of: planning, teaching, assessing and providing learning activities and tasks that are designed to the full intent of each standard. In addition, in partnership with Lead 180, the district has created a guaranteed and viable curriculum that is sustainable in the face of teacher turnover. 

### Reflection on the work completed during the 2020-2021 school year

The LEAD180 team was pleased to serve as a partner with the Decatur Public Schools team during their ongoing learning in regard to aligning instruction and learning to the rigor of College and Career Ready Standards. Our team worked on developing a common scope and sequence with cadres of teacher leaders and school/district administrators that represented all levels of schools across the district. The work of developing a common scope and sequence ensures that every school in the district is covering the critical content of a standards-based curriculum. Teams of teachers and leaders are currently continuing the work in greater depth as the Decatur team begins to create Learning Scales that will help guide the path toward proficiency within every standard outlined in the district scope and sequence.

The LEAD180 coaches are also engaged in professional learning focused on developing a common understanding of what rigor looks like at various levels through each standard and how these levels impact the design of instruction, student activity and the creating of student tasks and assessments.

The following outcomes were achieved this past school year:

- Understand the alignment from standard, objective, to learning target within the CCSS/IL State Standards and how that aligns to the IAR
- Practice utilizing rigor alignment tools to align authentic student work and assessments to CCSS/IL State Standards learning targets and standards and to the IAR.
- Unwrap standards into specific learning targets, and identify the level of rigor (DOK) for each learning target, using the Instructional Planning Toolkit
- Identify the priority standards for the grade level/content
- Break down which standards are being taught in each quarter and in what order (by unit)
- Provide other key details that may be needed for a high-level look at the entire year
- Prepare leaders to implement the rigor and alignment work through school-based PLCs

Teachers and school/district leaders responded positively to end of session surveys reporting over 90% of participants were either satisfied or extremely satisfied with the facilitation of sessions and having the opportunity to apply their prior knowledge to session activities.

### Session Feedback Survey Data Trends

#### • Rigor Session for Teachers and Leaders:

- 92% of teachers reported that the facilitators drew on their prior knowledge and/or experience and provided opportunities for practice and/or application.
- 93% of teachers reported they had opportunities to apply skills and knowledge presented through a variety of engagement activities.
- Common themes in the comments about what worked:
  - Enjoyed collaborating with other teachers to better understand rigor
  - Appreciated the tools and resources that were shared to make cognitive rigor more understandable
- Common themes in the comments for what could make it better:
  - Would like to work in a smaller group with their colleagues in their building for further work on this topic
  - Would like ideas for increasing rigor for struggling learners, Support to develop tiered assessments

### Proposed Scope of Work for the 2021-2022 School Year

The LEAD180 team I s looking forward to building on the great work that was started during the 2020-2021 school year. The focus of the work during the 2021-2022 school year will focus on the following areas:

#### **District Leadership Training**

Facilitate monthly sessions with principals to continue to build their skills as Specialists in Leading Standards-Aligned Instruction. Topics could include: Standards-Aligned Task Analysis, Feedback that Drives Rigorous Instruction, Assessment Literate Leadership, etc.

#### **Develop District End of Unit Assessments**

During the 20-21 school year, district-wide teams developed common scope and sequences for grades PK-12 in both Math and ELA. During the 21-22 school year, we will continue to build upon that work. District-wide teams will work together to develop common summative assessments for each unit of the previously created scope and sequence.

### School Level Coaching

LEAD180 Coaches will work with grade level teams within each building to bring the curriculum that was commonly developed during the 20-21 school year to life in the classrooms. The direction of this work will be determined by the building principal from a set of options provided by the district leadership. ### **Starks Consulting**

#### **Consulting Agreement**

This is a contract (this "**Agreement**") entered into by <u>Starks Consulting, Chicago LLC</u>, with its primary address at Chicago, Illinois 60652 and <u>Decatur Public Schools</u> (hereinafter referred to as "**Client**"), with its primary place of business at 101 W. Cerro Gordo Street Decatur, IL 62523 (collectively, the "**Parties**" and each a "**Party**").

**1. Term.** This Agreement is effective as of July 1, 2021, and will continue through May 30, 2022 (the "**Termination Date**") unless extended by mutual written agreement.

**2. Description of Services to be Performed.** Beginning on July 1, 2021, Starks Consulting shall provide the services (collectively, the "Services") as referenced in <u>Exhibit</u> <u>A</u>.

**3. Payment for Services Performed.** In consideration of Stark's performance of Services in accordance with the terms of this Agreement, Client agrees to compensate Starks as follows (the "**Fee**"): \$180,000 to be paid in monthly payments of 16,363.63, invoiced on the 1st of each month beginning August 1, 2021, through June 1, 2022.

The maximum total fee authorized by this Agreement will be \$180,000 per the term of the Agreement.

Additionally, Client shall, promptly upon request as provided below in this Section, reimburse Starks for reasonable and necessary expenses approved by Client in writing in advance.

Starks shall send an invoice to the Client in order to be compensated for Services and, if applicable, reimbursed for approved expenses that have been incurred.

**4. Ownership of Work Product**. Client and Starks understand and agree that all work and work products prepared by Starks in connection with Starks' services under this Agreement, including all intellectual property rights therein (collective, "**Work Product**"), will be and remain the sole property of Starks. Starks will have full, exclusive, and unlimited right to use or reprint such Work Product and to transfer such right to others, and Client shall have no right, title, or interest in or to the Work Product.

**5. Termination.** This Agreement may be terminated prior to the Termination Date by either Party (a) for any reason or for no reason, upon thirty days written notice to the other Party or (b) in the event that the other party defaults in the payment or performance of its obligations under this Agreement and such default are not cured on or before the tenth (10th) day after the date on which the non-defaulting Party delivers written notice to the defaulting Party, in which case this Agreement shall terminate automatically and without further notice on the day after such tenth (10th) day.

**6. Independent Contractor**. The parties agree that in performing the Services, Starks will be an independent contractor and not an employee of Client for purposes of all state, federal, and local laws.

**7. Release and Indemnification.** Starks hereby release, discharge, and agree to hold harmless and defend Client and its directors, officers, employees, and agents from any liabilities, losses, claims, suits, damages, costs, and expenses, including without limitation reasonable attorneys' fees (collectively, "**Damages**") arising out of or otherwise relating to the subject matter of this Agreement and resulting from the acts or omissions of Client or any of its directors, officers, employees, and agents, <u>provided</u> that the foregoing indemnity shall not apply to any Damages to the extent that the same arises from any action or omission by Client in violation of this Agreement or constituting fraud.

Client hereby releases, discharges, and agrees to hold harmless and defend Starks Consulting and its directors, officers, employees, and agents from any liabilities, losses, claims, suits, damages, costs, and expenses (including without limitation, reasonable attorneys' fees, defense costs, investigation expenses, discovery costs, and court costs) arising out of or otherwise relating to the subject matter of this Agreement and resulting from the acts or omissions of Starks or any of its directors, officers, employees, and agents, <u>provided</u> that the foregoing indemnity shall not apply to any Damages to the extent that the same arises from any action or omission by Starks in violation of this Agreement or constituting fraud.

**8.** No Solicitation. Throughout the Term of this Agreement and for a period of [*one* (1) year] after the Termination Date or, if earlier, the date on which this Agreement is terminated pursuant to Section 5, neither Party shall knowingly directly or indirectly attempt to employ, or solicit for employment by others, any person who is then, or was within the preceding twelve (12) months, an employee or independent contractor of the other Party.

**9. No Assignment.** Onward may not assign or transfer any of its rights hereunder or delegate any of its obligations hereunder without Client's prior written consent, which Client shall not unreasonably withhold, delay or condition. Any attempted assignment or transfer without such consent will be void.

**10. Applicable Law.** This Agreement shall be governed by the laws of the State of New York, without regard to principles of conflict of laws.

**11. No Waiver.** The waiver by either party of a breach or violation of any provision of this Agreement will not constitute a waiver of any subsequent breach or violation thereof.

**12. Enforceability.** If any provision of this Agreement is found to be void or unenforceable by either of the parties, such finding will not render any other provision of this Agreement void or unenforceable.

**13. Entire Agreement.** This document contains the entire Agreement of the parties and supersedes all prior negotiations or agreements, whether oral or written, regarding the matters set forth herein. It may not be changed orally but only by an agreement in writing signed by both parties.

**14. Dispute Resolution**. The parties agree that any controversy, claim or dispute of whatever nature arising between the parties shall be resolved exclusively through binding arbitration in Chicago, Illinois before a single arbitrator, pursuant to the American Arbitration Association's then-in-effect National Rules for the Resolution of Commercial Disputes.

**15. Binding Effect**. This Agreement shall be binding on, and inure to the benefit of, the Parties and their respective successors and permitted assigns.

### **BACKGROUND INFORMATION:**

DPS K-12 teachers and stakeholders were provided the opportunity to pilot 2 Social Studies curriculumresources they had been utilizing from the Fall of 2020 school year to recent. There were 2 different programs used at a variety of buildings.

#### **CURRENT CONSIDERATIONS:**

DPS K-12 Pilot teachers evaluated the programs using the Social Studies and Anti-Racist/Anti-Biased rubric to include in their findings during the presentation to staff. DPS K-12 pilot teachers virtually presented their feedback to staff over 2 different sessions. As the decision to determine which Social Studies program was preferred for our district, data was gathered outlining the overall percentage, based upon the program piloted utilized a virtual presentation and closing survey to determine curriculum/resource preference. The outcome of the data analyzed and disaggregated determined that the district wide Social Studies curriculum program that is preferred by K-12 teachers is McGraw Hill.

# **BACKGROUND INFORMATION:**

The Johns Hill building is being decommissioned through the Health/Life Safety process and is scheduled to be raised to make room for the north bus loop as part of the new Johns Hill construction. In addition, the Oak Grove facility and the Quonset Hut located at Pigott Field are also scheduled for demolition.

At the March 23, 2021 board meeting, this item was tabled due to the lack of agreement on the Project Labor Agreement (PLA) with the lowest bidder. Administration was provided guidance to rebid and in this process has ensured that this bid meets the PLA and Minority Business Enterprise goals as mentioned below under current considerations.

# **CURRENT CONSIDERATIONS:**

The District received five competitive bids with the low bid from JL Sullivan Services, Inc. (Banks Excavating). The PLA was part of the bid packet; and, JL Sullivan Services, Inc. (Banks Excavating) has met the Minority Business Enterprise goals as noted in the attached report from Coleman and Associates, Inc.

# FINANCIAL CONSIDERATIONS:

The bid from JL Sullivan Services, Inc. (Banks Excavating) came back lower than the initial bid that was previously presented to the Board.

The low base bid, which includes the demolition of the Quonset Hut, is for a total of \$1,061,198 with the following breakdown:

- Johns Hill Demolition: \$462,975
- Johns Hill Abatement: \$89,999
- Oak Grove Demolition: \$243,440
- Oak Grove Abatement: \$264,784

# **STAFF RECOMMENDATION:**

# Good Faith Effort Committee Recommendation

The recommendation is that the documentation of good faith effort by the lowest bidder IS sufficient to have them determined as a responsive bidder. Therefore, the award of this project to the lowest responsive and responsible bidder is recommended to go forward.

The recommendation is based on the inclusion of a single MBE subcontractor that will perform seeding/mulching, provide fertilizer, a silt fence and trucking/hauling.

## Analysis

J.L. Sullivan Services, Inc. (dba Banks Excavating) submitted an MBE utilization plan on bid day that yielded 13.3% planned utilization of Marenco Enterprises LLC. Because the utilization plan fell short of the MBE goal, good faith effort was initiated. Additional information requested included:

1) The **solicitation** sent to all MBEs to solicit quotes for scopes of work J.L. Sullivan Services, Inc. (dba Banks Excavating) were interested in subcontracting. Dates solicited, whom contacted, whom spoken with, and any findings or conclusions from solicitation effort(s).

2) The **quote** for scope of services received from any MBEs to provide J.L. Sullivan Services, Inc. (dba Banks Excavating) those services

3) If J.L. Sullivan Services, Inc. (dba Banks Excavating) negotiated an oral quote, state in an email the date, time and content of the conversation(s) and final conclusion on price and services accepted in order to subcontract or not. Please note the Letter of Intent to Subcontract is in DPSD #61 possession and I am seeking additional information.

4) MBE certification profile for Marenco Enterprises LLC not included with the bid package per directions in bidding documents. This profile is found in the City of Decatur ePrism database.

5) A letter on company letterhead that states J.L. Sullivan Services, Inc, (dba Banks Excavating) mistakenly did not include in the scope of services within the Letter of Intent to Subcontract with Marenco Enterprises LLC "trucking/hauling" services.

Items 1 through 4 were received before close of business April 29. The consultant requested and received item 5 on April 30. The additional documentation was reviewed by the consultant.

# Methodology

Per documentation received from J.L. Sullivan Services, Inc. (dba Banks Excavating), the prime contractor solicited two local Decatur trucking/hauling contractors out of a total of six listed in the site work MBE list provided to prime contractors during rebid. J.L. Sullivan Services, Inc. (dba Banks Excavating) accepted a bid from one of the two. The second MBE trucking/hauling vendor did not respond to the solicitation.

Per documentation received from J.L. Sullivan Services, Inc. (dba Banks Excavating), the prime contractor solicited two landscaping services firms. These two were the only two landscaping firms listed in the site work MBE list. J.L. Sullivan Services, Inc. (dba Banks Excavating) accepted a bid from one of the two MBE vendors and rejected a bid from the second due to a significantly higher price.

(dba Banks Excavating) indicated in oral discussions with the consultant to use Marenco Enterprises LLC for trucking/hauling for approximately \$124,210 (11.70% MBE utilization). The Letter of Intent to Subcontract did not include "trucking/hauling" in the scope of services section. The consultant requested and received a letter clarifying trucking/hauling is part of the original intent to subcontract with Marenco Enterprises, LLC.

## Decatur School Board Members Should Apologize

At the very least, the current District 61 Board of Education owes the Decatur community a public apology for their conduct these past four years. The terms of board members have been marred by arrogance, deceitfulness and illegal actions.

Additionally, their treatment of the media, more specifically WAND's Chris Carter, is shameful. Hanging up on him is intolerable, when he was only doing his job to find the truth and report it to the public. Subsequently, two public relation/communication employees of District 61 wrote horrible, ugly texts about Mr. Carter. These two individuals should have been terminated for the vile language and their attempt to cover up information.

The recent release of recordings of closed meetings concerning assistant superintendent Jeff Dase shows that either the board or Mr. Dase is not telling the truth about who initiated the proposal for the \$30,000 bonus. A board member is quoted as saying, "what he's asking for, what he's asking us to do." This implies that Mr. Dase was the one who proposed this to the board. Some members "talked a big talk" four years ago when they were running for election; to the point that three of them formed a pact and promised to make significant improvements in the district so that we become a "destination district". The public deserves to know what those improvements are and how that has made Decatur a "destination" district.

We continue to hear from elected officials at all levels of government about how they strive for transparency. Transparency is not an elusive term that is difficult to grasp. Transparency is honesty and it should be a goal and the way every official should serve the public. A genuine, honest apology is in order so please tell us that you are sorry for your conduct.

It's the very least the board of education can do and our community deserves it.

Tonight is the last board meeting for four BOE members.

I believe that each of those members ran with good intentions. Because of the efforts of those intentions, some students and schools have benefited greatly in the past four years. Unfortunately, others have not. The single-minded focus on sticking to the BOLD plan to save face blinded them from the real impact of all the mergers. These mergers – that we now know were ill-planned and short-sighted – caused chaos and our children's education suffered.

We have seen a decline in enrollment and a staff shortage due to an increasing number of staff leaving. Staff and parents have come before this board pouring their hearts out about how they have been treated and their concerns. Unfortunately, it fell on deaf ears.

In the past four years, this board has:

- violated the Open Meetings Act multiple times.
- consistently undermined the teaching staff, including the board president stating Teaching Assistants simply, "walk students from class to class" and supporting unnecessary fact-finding mandates.
- promoted and awarded skewed data.
- Nurtured a culture that advocated an overall lack of transparency.

Even now, when all this information has been made public, it is still really hard to know what is true and what is part of their agenda because the narratives are still being handled by their hires and/or friends.



# **BACKGROUND INFORMATION:**

In FY18 the Board entered into a three year agreement for auditing services with BKD CPAs and Advisors. The agreement ended last year; however, the bid documents stated that *Contracts may be extended for up to two additional years by mutual agreement of the parties, and thereafter may be extended on a year-to-year basis by mutual agreements of the parties.* 

# **CURRENT CONSIDERATIONS:**
