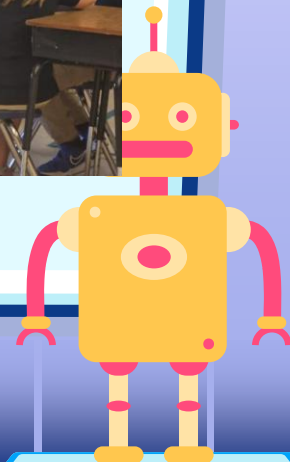
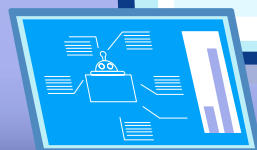

POLICY: 6:300 New Graduation Requirements

I. Overview: Beginning with the class of 2028, a minimum of 24 credit hours is required for graduation from Decatur Public High Schools.

Current Juniors (Class of 2027) & Seniors (Class of 2026)	22
Current Freshmen (Class of 2029) & Sophomores (Class of 2028) and all classes beyond	24

POLICY: 6:300 New Graduation Requirements Cont.

II. Student classification levels

Student Classification	Number of credits needed
Freshman	Less than 5 credits
Sophomore	5 – 11 credits
Junior	12-17 credits
Senior	18 credits and above

Note: Effective immediately, students who do not acquire the appropriate number of credits to be classified at the next classification level will be reclassified each year based on their credit attainment.

FAQs

1. Why raise the credit requirements for graduation? Requirements are comparable to surrounding counties and allow us to raise the bar for students relative to preparation for college, military or the workforce.
2. What will this do to class sizes for Freshmen? Little change will occur given the number of electives available.
3. What will this do for students' access to sports? No Change (C or above).
4. How will this impact students needing credit recovery? APEX is available for students (APEX 50-59; full APEX courses with similar difficulty to in-person learning, Summer School).

FAQs

5. What about current Seniors? Seniors are not impacted; their credit requirement remains **22**. This is the same for Juniors.

6. What classes will be offered to make up the 2 additional credits? We have added several electives to the Course Guide over the past two years in Career and Technical Education, etc. to support this change.

7. Does this apply to special needs children? Special needs students can earn a regular diploma by meeting the same requirements as their non-special needs peers with modifications outlined in their IEPs. *Note: Special needs students may also receive a certificate of completion with extended learning opportunities or a certificate of attendance.

INSTRUCTION

6:300 Graduation Requirements

To graduate from high school, unless otherwise exempted, each student is responsible for:

1. Completing all District graduation requirements that are in addition to the State requirements.
2. Completing all courses as provided in the School Code, [105 ILCS 5/27-22](#).
3. Completing all minimum requirements for graduation as specified in State law.
4. Passing an examination on patriotism and principles of representative government, proper use of the flag, methods of voting, and the Pledge of Allegiance.
5. Participating in State assessments that are required for graduation by State law.
6. Filing one of the following: (1) a Free Application for Federal Student Aid (FAFSA) with the U.S. Dept. of Education, (2) an application for State financial aid, or (3) an Ill. State Board of Education (ISBE) waiver form indicating that the student understands what these aid opportunities are and has chosen not to file an application. If the student is not at least 18 years of age or legally emancipated, the student's parent/guardian must file one of these documents on the student's behalf.

A student is exempt from this requirement if: (1) the student is unable to file a financial aid application or an ISBE waiver due to extenuating circumstances, (2) the Building Principal attests the District made a good faith effort to assist the student or the student's parent/guardian with filing a financial aid application or an ISBE waiver form, and (3) the student has met all other graduation requirements.

The Superintendent or designee is responsible for:

1. Maintaining a description of all course offerings that comply with the above graduation requirements.
2. Notifying students and their parents/guardians of graduation requirements.
3. Developing the criteria for #4 above.
4. Complying with State law requirements for students who transfer during their senior year because their parent(s)/guardian(s) are on active military duty. This includes making reasonable adjustments to ensure graduation if possible, or efforts to ensure that the original (transferor) school district issues the student a diploma.
5. Taking all other actions needed or necessary to implement this policy.

Beginning with the class of 2028, a minimum of 22 **24** credit hours is required for graduation from Decatur Public High Schools. One half (0.5) credit is earned upon successful completion of each semester course.

Early Graduation

The Superintendent or designee shall implement procedures for students to graduate early, provided they meet all graduation requirements.

Certificate of Completion

A student with a disability who has an Individualized Education Program prescribing special education, transition planning, transition services, or related services beyond the student's four years of high school, qualifies for a certificate of completion after the student has completed four years of high school. The student is encouraged to participate in the graduation ceremony of his or her high school graduation class. The Superintendent or designee shall provide timely written notice of this requirement to children with disabilities and their parents/guardians.

Service Member Diploma

The District will award a diploma to a service member who was killed in action while performing active military duty with the U.S. Armed Forces or an honorably discharged veteran of World War I, the Korean Conflict or the Vietnam Conflict, provided that he or she (1) resided within an area currently within the District at the time he or she left high school, (2) left high school before graduating in order to serve in the United States Armed Forces and (3) has not received a high school diploma.

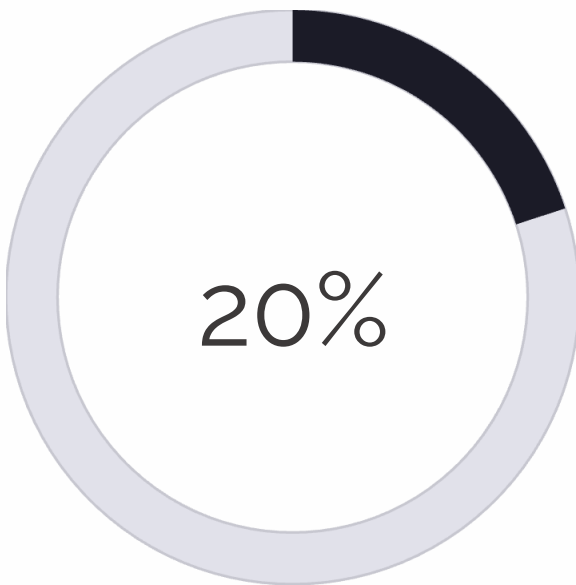


District Performance Overview

Significant Annual Performance Advancement

The district registered a **4.6-point increment** in overall performance from the 2023-2024 school year. This constitutes a **20.07% variance**, reflecting substantial advancement across multiple key indicators.

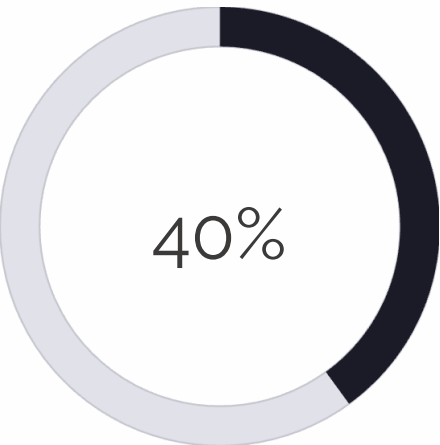

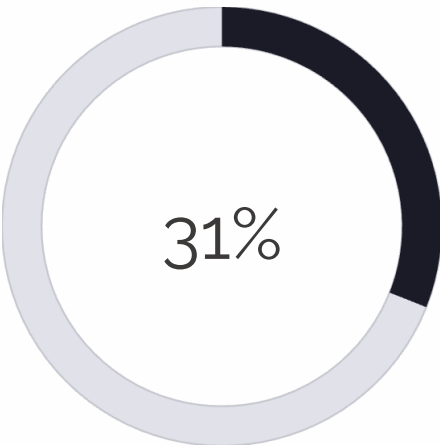

Ninth-Grade On-Track Performance Analysis

Ninth-grade on-track performance metrics serve as critical indicators for high school graduation success. Students achieving requisite academic credits and satisfactory grade performance during their inaugural year exhibit a substantially elevated likelihood of graduating within the standard timeframe.

Eisenhower High School: Performance Overview

64.09% of ninth-grade cohort achieved on-track status.

↑ 0.41 percentage points from the prior reporting period (63.68%).

This incremental gain underscores a sustained strategic commitment to first-year student support frameworks and proactive intervention protocols.

MacArthur High School: Performance Overview

76.38% of ninth-grade cohort achieved on-track status.

↓ 1.88 percentage points from the prior reporting period (78.26%).

Despite a marginal deceleration in growth, MacArthur High School consistently maintains an on-track attainment rate significantly surpassing the statewide average.



Composite Graduation Rate Analysis

Both educational institutions exhibited favorable trends in composite graduation rates, marked by significant advancements that underscore the effectiveness of sustained student support initiatives implemented throughout the academic tenure.

Composite graduation rates integrate the 4-year, 5-year, and 6-year adjusted cohort graduation rates. This methodology provides a comprehensive perspective on student academic progression across multiple cohorts, by continuously tracking student cohorts from initial ninth-grade enrollment, inclusive of transfers, thereby yielding a more holistic assessment than singular annual metrics.

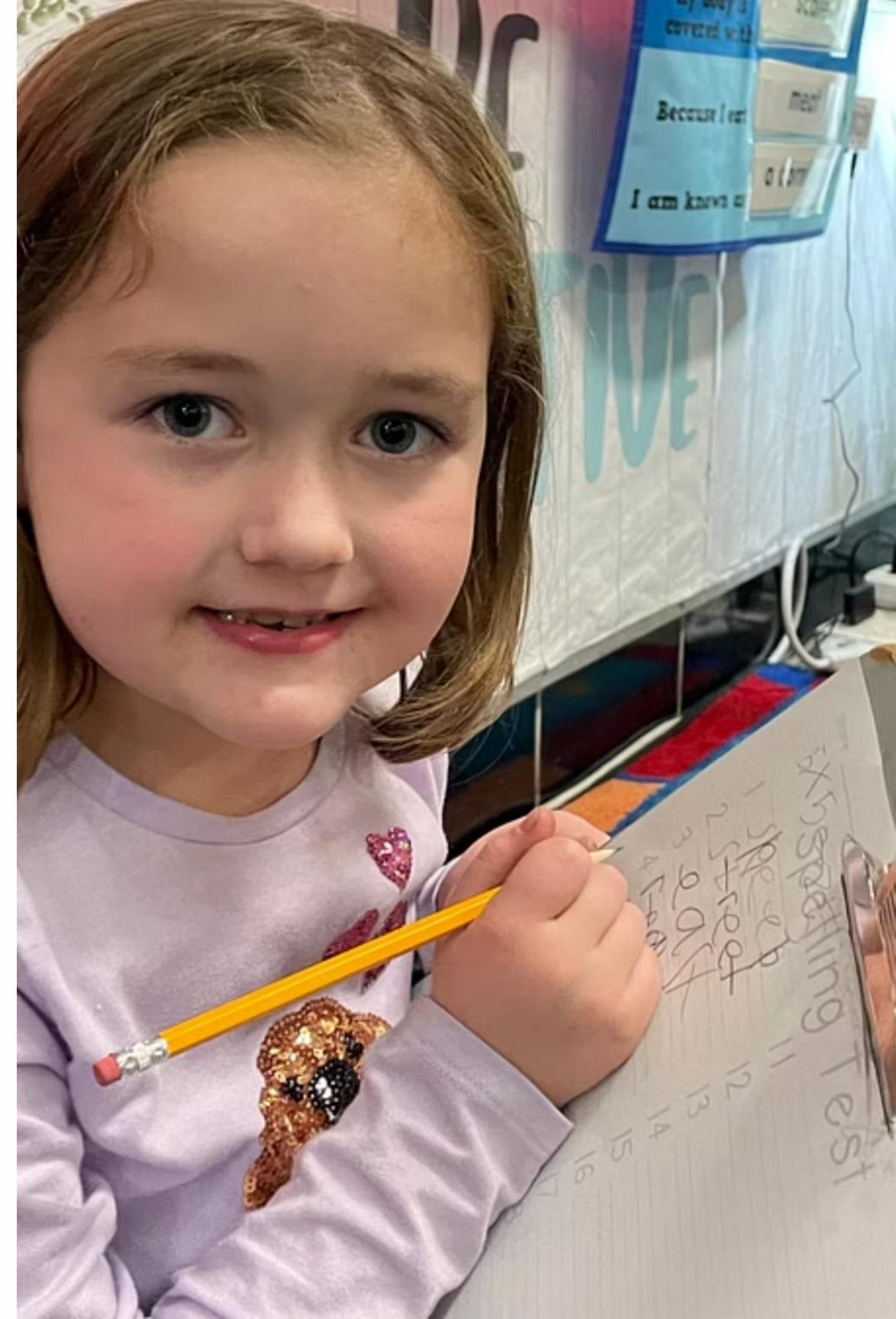

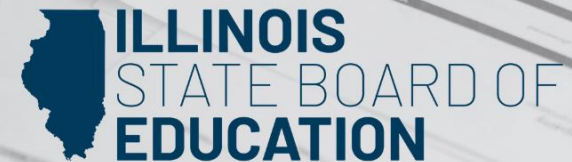

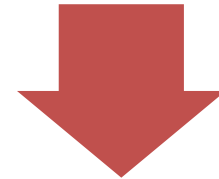

Purpose of the Tax Levy

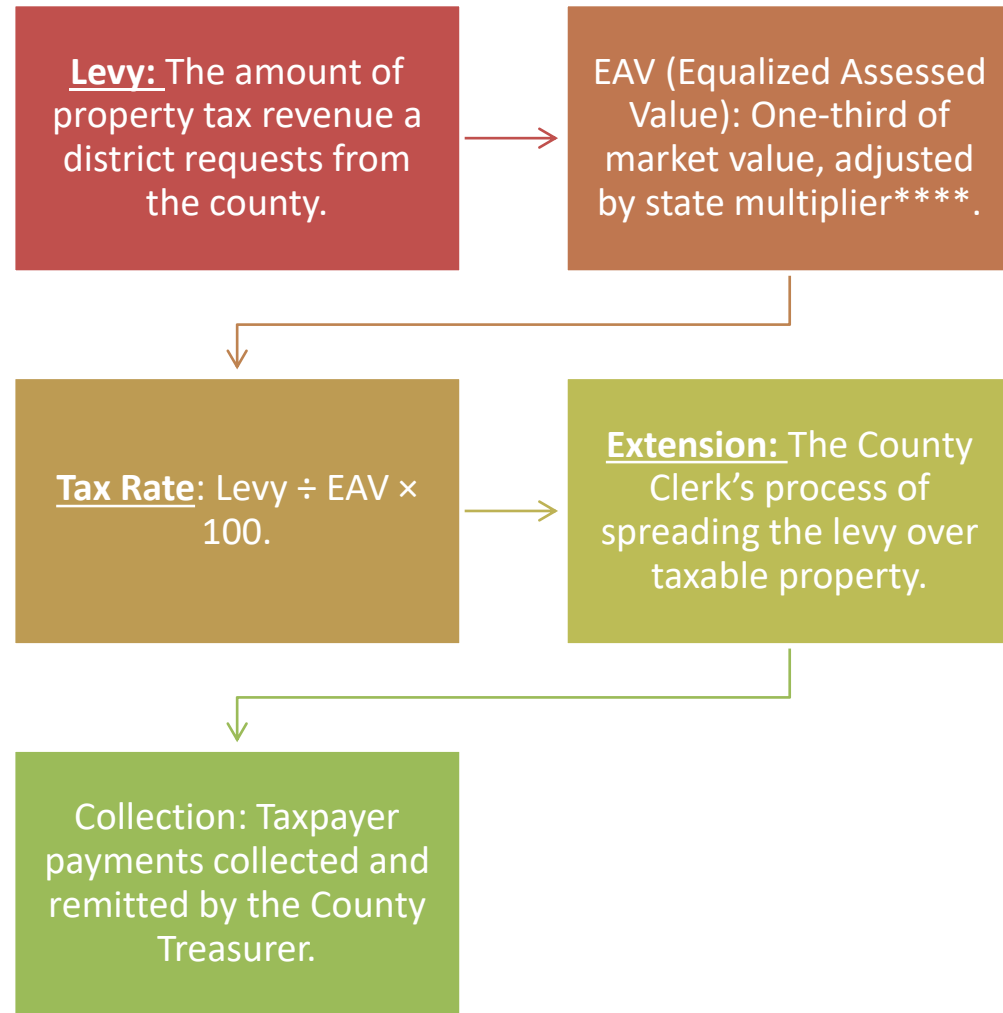
The tax levy is the school district's annual legal request for property tax revenue.

Provides the largest single source of local funding for most Illinois districts.

Levy determines the amount to be extended on the Equalized Assessed Value (EAV) base by the County Clerk.

Adopted annually by the Board of Education and filed by the last Tuesday in December.

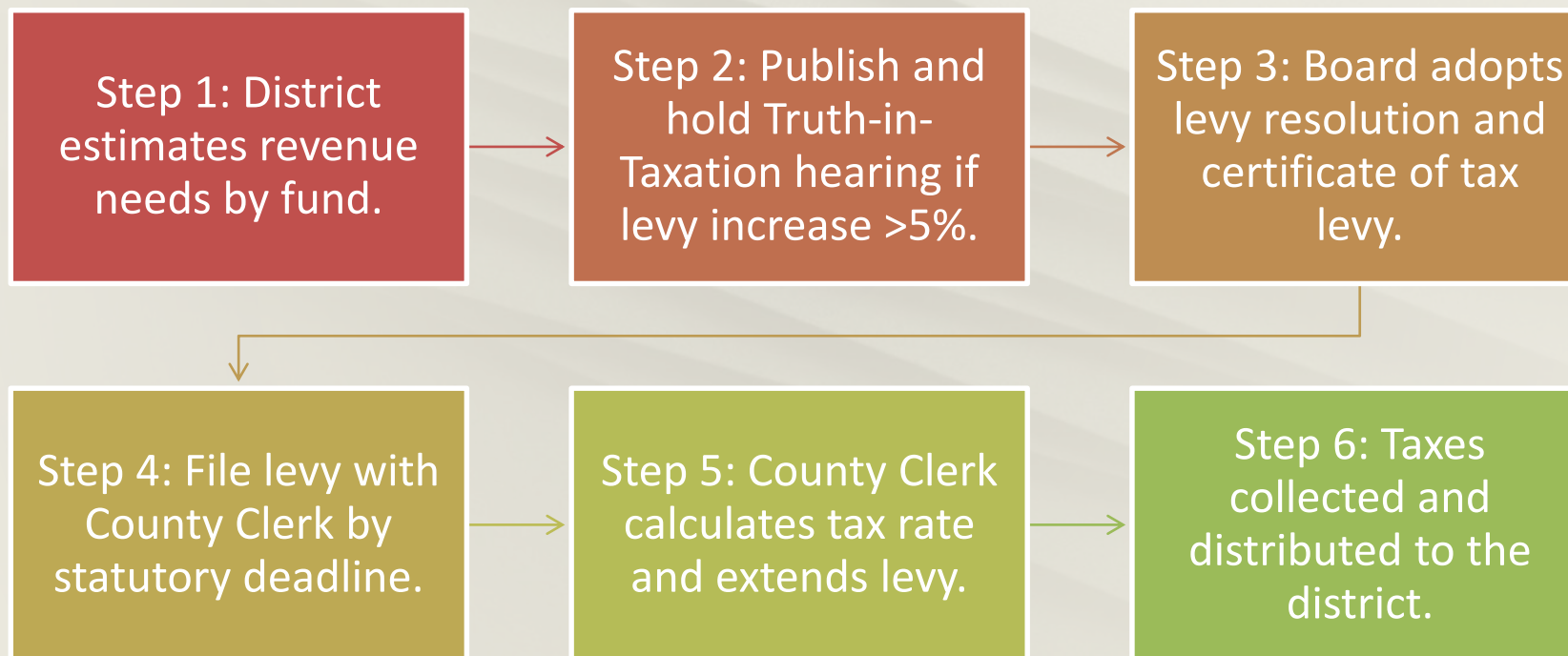

Tax Levy Process Overview



Truth in Taxation Act Requirements



Applies if levy increase exceeds 105% of prior year extension (5% more than prior year). If the EAV increase is estimated to be over 5% - prudent to publish a TnT.



District must publish notice in a local newspaper (not more than 14 and not less than 7 days before hearing).



Public hearing must be held before adoption of levy.

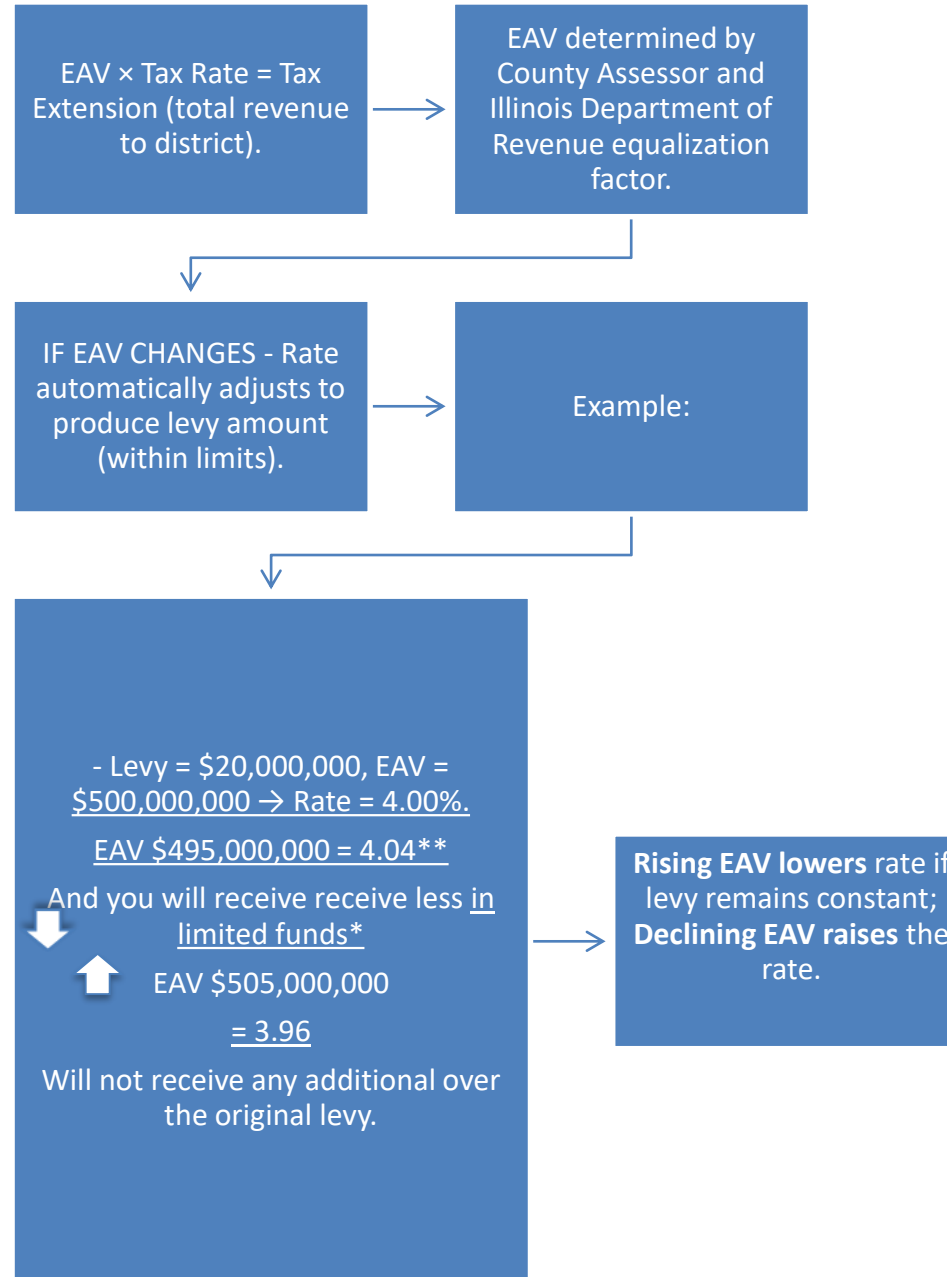


Board must approve levy by roll call vote following hearing.



Promotes transparency and community engagement.

Understanding EAV and Tax Rate Relationship



Non- PTELL Districts

Non-PTELL districts are not subject to CPI-based tax caps.

May increase levy based on EAV growth or voter-approved authority.

Can capture all new property and inflation growth automatically.

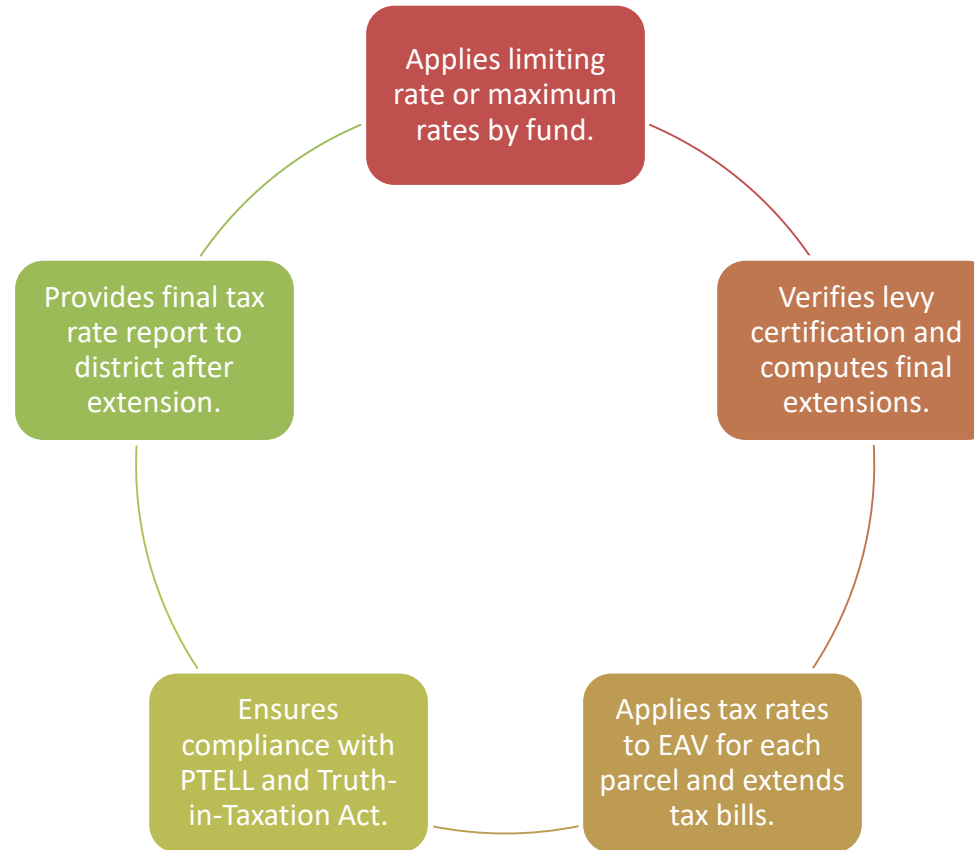

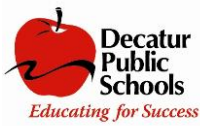

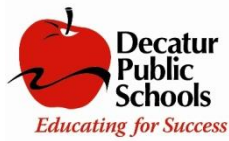

BACKGROUND INFORMATION:

The Board Policy Committee regularly reviews Policies to adjust based on the Illinois Association School Boards PRESS recommendations, current practices, needed changes to practices, and updates to reflect changes associated with new laws. The policies are reviewed by the Board Policy Committee and the best corresponding administrator(s). Currently, administration is recommending a change to the above policy regarding graduation requirements for students.

CURRENT CONSIDERATIONS:

Administration is recommending that at the beginning of the Class of 2028, a minimum of **24** credit hours is required for graduation from Decatur Public High Schools; this would be an increase from 22 to 24. The required electives would increase from 4 to 6.

The current juniors and seniors would remain with 22 credit requirements in order to graduate. However, the current freshmen and sophomores and all classes beyond would need 24 credits in order to graduate from Decatur Public Schools.

Students would also be classified as a freshman, sophomore, junior and senior by the number of credits they earn each year. Students must earn the appropriate number of credits for each class in order to move forward to the next classification level. ***Note: Effective immediately, students who do not acquire the appropriate number of credits to be classified at the next classification level will be reclassified each year based on their credit attainment.***

INSTRUCTION

6:300 Graduation Requirements

To graduate from high school, unless otherwise exempted, each student is responsible for:

1. Completing all District graduation requirements that are in addition to the State requirements.
2. Completing all courses as provided in the School Code, [105 ILCS 5/27-22](#).
3. Completing all minimum requirements for graduation as specified in State law.
4. Passing an examination on patriotism and principles of representative government, proper use of the flag, methods of voting, and the Pledge of Allegiance.
5. Participating in State assessments that are required for graduation by State law.
6. Filing one of the following: (1) a Free Application for Federal Student Aid (FAFSA) with the U.S. Dept. of Education, (2) an application for State financial aid, or (3) an Ill. State Board of Education (ISBE) waiver form indicating that the student understands what these aid opportunities are and has chosen not to file an application. If the student is not at least 18 years of age or legally emancipated, the student's parent/guardian must file one of these documents on the student's behalf.

A student is exempt from this requirement if: (1) the student is unable to file a financial aid application or an ISBE waiver due to extenuating circumstances, (2) the Building Principal attests the District made a good faith effort to assist the student or the student's parent/guardian with filing a financial aid application or an ISBE waiver form, and (3) the student has met all other graduation requirements.

The Superintendent or designee is responsible for:

1. Maintaining a description of all course offerings that comply with the above graduation requirements.
2. Notifying students and their parents/guardians of graduation requirements.
3. Developing the criteria for #4 above.
4. Complying with State law requirements for students who transfer during their senior year because their parent(s)/guardian(s) are on active military duty. This includes making reasonable adjustments to ensure graduation if possible, or efforts to ensure that the original (transferor) school district issues the student a diploma.
5. Taking all other actions needed or necessary to implement this policy.

Beginning with the class of 2028, a minimum of 24 credit hours is required for graduation from Decatur Public High Schools. One half (0.5) credit is earned upon successful completion of each semester course.

Early Graduation

The Superintendent or designee shall implement procedures for students to graduate early, provided they meet all graduation requirements.

Certificate of Completion

A student with a disability who has an Individualized Education Program prescribing special education, transition planning, transition services, or related services beyond the student's four years of high school, qualifies for a certificate of completion after the student has completed four years of high school. The student is encouraged to participate in the graduation ceremony of his or her high school graduation class. The Superintendent or designee shall provide timely written notice of this requirement to children with disabilities and their parents/guardians.

Service Member Diploma

The District will award a diploma to a service member who was killed in action while performing active military duty with the U.S. Armed Forces or an honorably discharged veteran of World War I, the Korean Conflict or the Vietnam Conflict, provided that he or she (1) resided within an area currently within the District at the time he or she left high school, (2) left high school before graduating in order to serve in the United States Armed Forces and (3) has not received a high school diploma.

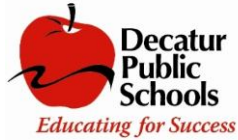

An estimated EAV will be presented at the November 11th Board meeting. Dr. Curry will provide multiple tax levy options at this meeting.

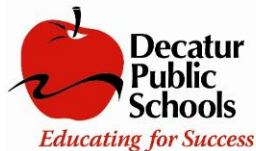

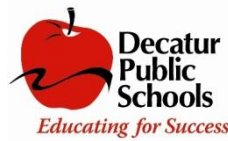
