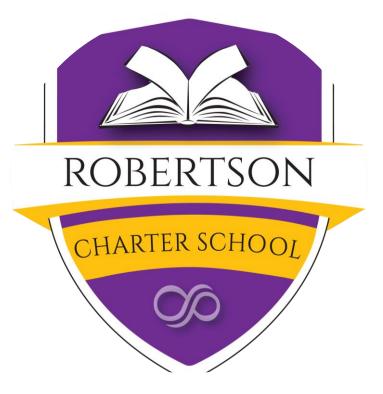

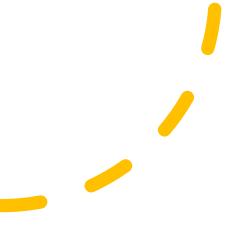

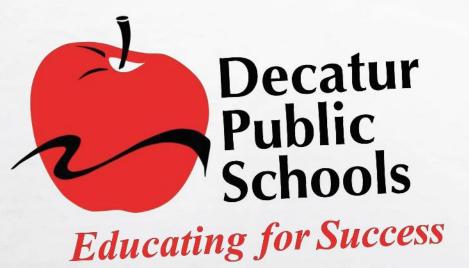

BACKGROUND INFORMATION:

The Board Policy Committee, in collaboration with student ambassadors and members/graduates of the Decatur Public Schools Parent Leadership Training Institute (PLTI), met to develop a racial equity policy. *The policy will guide the District's equity work in an effort to reduce the effects of racism on the District's Black, Latina, and other marginalized students, families, staff and community in support of the Teaching and Learning of Decatur Public School District.*

CURRENT CONSIDERATIONS:

Committee updates regarding the Resolution on Racism were presented at the November 4th Board of Education Meeting. It was stated during this presentation that the first reading of the Racial Equity Policy would be presented at the November 17th Board of Education meeting.

FINANCIAL CONSIDERATIONS:

There are no specific costs associated with the adoption of the racial equity policy.

Equal Education Opportunities - Racial Equity

The Decatur Public Schools District #61 acknowledges that complex societal and historical factors contribute to inequities within the Decatur Public School District. This history has negatively impacted the health, education, and economic outcomes for many students. This policy confronts the institutional bias that results in predictability of student performance based on race, background, and/or circumstances (such as, but not limited to: disability, language, income, and culture). Decatur Public Schools is committed to the District mission of unlocking "students' unique and limitless potential to achieve their personal aspirations as fully prepared, contributing citizens in a global society." To achieve this, the District resolves to address opportunity gaps at every level of the organization through policy, procedure, and practice in order to eliminate persistent achievement gaps.

Educational equity benefits all students and the entire community. The diversity of the student body, administration, staff and community is a strength of this district and should be fostered. Decatur Public Schools District #61 believes the responsibility for student success is broadly shared by District staff, families, our community and each student's individual efforts. Each student deserves a learning environment in which diversity is valued and contributes to successful academic outcomes. To that end, Decatur Public Schools District #61 commits to:

- Developing or revising policies and protocols that integrate additional racially and culturally relevant content, along with anti-racism instruction, into the curriculum;
- Implementing an aligned, culturally responsive social-emotional learning curriculum;
- Ensuring the district calendar is inclusive of important cultural holidays celebrated by our students, their families, our staff, and our community;
- Providing mandatory diversity and inclusion, equity, cultural relevancy, and implicit bias training to all who work, volunteer, intern, and/or interact with district students;
- Aggressively recruiting and developing teachers and staff who reflect the diversity of our students;
- Developing a discipline and safety system that protects the physical, mental, and social health of students and staff through a culturally responsive, restorative justice model;
- An annual conversation with a representative group of students, the Chief of Police, and other district stakeholders regarding the SRO contract renewal;
- Establishing Employee Resource Groups focused on supporting and improving retention, morale, professional growth, and opportunities for teachers and staff;
- Regular reports regarding the education outcomes of all students (disaggregated by race and other intersectional categories, including but not limited to: socioeconomic status, gender, etc.) regarding curriculum, discipline, opportunities, and social climate; and
- Preparing an annual report to the community that highlights District progress toward these goals.

Emphasis on Fine Arts

- Arts Education Specialists has implemented one-year comprehensive plan specific to each building's fine art needs
- Tracking metrics to determine success of Fine Arts program goals, including tracking increase in arts enrollment district-wide

Associate's Degree Program

- The PREP Academy Associate's Degree Program has been developed in partnership with Richland Community College
- Unique opportunity to jumpstart college education, only offered to DPS students
- Will provide DPS students FREE access to earn H.S. diploma + Associate's Degree in four years during high school
- Talks continue with DEA as to implementation of program

Strengthen Advisory/Counseling Programs

- Monthly meetings are scheduled to address priorities + roles and responsibilities of advisory/counseling programs
- Goal = provide not only instructional supports but also wrap around supports that include, but are not limited to, dual credits, internships, SEL, etc.



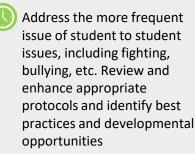

- Survey will be sent out later this month, data will be compiled to determine interest in program

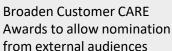

Historically, the district has purchased a service agreement to provide 24 hour/seven day a week support of the District's network. This support provides continuous monitoring of District's dvices including Cisco Cisco catalyst switches, routers, and VoIP phone gateways.

This collection of devices, know as the Universal Computer System (UCS), is comprised of 40+ servers and is housed in the main data center. Both EHS and MHS have a Cicso wireless network infrastructure which is covered. Other district locations that use the Meraki equipment is covered under a different agreement.

The District's network is critical for a functional Teaching and Learning enviroment.

CURRENT CONSIDERATIONS:

The agreement provide the annual renewal for the 24/7 support of District equipment.

FINANCIAL CONSIDERATIONS:

The cost of the Smartnet agreemtn is \$89,313.48 and would be paid from the FY21 Information Technology Budget.

My name is Carla Burger. I am a retired district employee who worked in the Business Office for over 37 years.

At the October 13th BOE meeting, the Board approved "bonus" compensation for four principals and two support staff members totaling \$6,940.00. On the agenda for tonight's BOE meeting, the Board was asked to approve "bonus" compensation for the Assistant Superintendent of Teaching & Learning for the amount of \$30,000.00.

In the minutes of the October 13th BOE meeting, it was noted that the Board discussed and created the Administrators and Administrative Support Bonus Pool in 2019. It is also noted that Jeff Dase, the Assistant Superintendent of Teaching & Learning was given the task to develop the framework and implementation of this "bonus" pool. Tonight the Board was asked to approve a "bonus" to the employee they assigned to implement this "bonus" pool. Does this not make you feel a little uncomfortable?

The salaries and benefit compensation for FY2020 for five of these employees receiving "bonus" compensation is listed on the district's website. The base salaries range from \$80,000.00 to \$133,000.00. Mr. Dase's contract states his 2020-2021 base salary is over \$156,000.00. In addition to their base salaries, each of these employees receives a generous benefit package from the district. A large portion of their health insurance premiums are paid by the district. They receive paid vacation and sick days each year. Those that work year round have fifteen paid holidays off from work. They are all well compensated by the district. Is this not enough for them to do the job they were hired to do? Why is a bonus necessary?

I have many questions about this "bonus" pool. Were the details of the final plan presented to and approved by the Board at a public meeting?

Who submits names to be considered? What is the criteria used to determine if a "bonus" is approved and for what amount? Who makes this decision? Are details about this "bonus" pool available to the public?

Some people will ask if all district employees will be able to receive "bonuses". I would like to ask that the six or seven "bonuses" that have been approved by the Board be retracted and this "bonus" pool be abolished. No disrespect to the employees already approved for "bonuses", but this seems like a way to give the district's favorite employees something extra. This is not a good thing for employee morale. It also is not an ethical or responsible way for the district to spend taxpayer dollars that should be used for the students of the district.

As a taxpayer, I was confused by the board awarding a five year contract extension to Assistant Superintendent, Jeff Dase. He was hired in April 2019 and had less than a year in the position with in person learning before the pandemic struck. The district is in disarray with pacing guides that are designed for in person learning that are being enforced for virtual learning for classes that are of shorter duration than the in person classes. Teachers are being told and some reprimanded for using X's for modules that cannot be assessed, which is what the guidelines told them to do. Hello,

I am a DPS parent who has had growing concerns about my school district over the last year. I was saddened about the impasse between the board and the teaching assistants, and felt it was not well handled.

I was puzzled by the decision to grant a five year extension to an administrative employee with 16 months left in an initial contract. I don't understand why that step is necessary. It seems to me the point of an initial two-year contract is to afford ample time to properly assess one's performance before offering an extension. For the record, I'd be equally perplexed by a decision to terminate someone after eight months—save an egregious scandal.

More recently, I've been disheartened by the treatment of our teaching staff during the pandemic over grade reports. I feel that one of the greatest threats to the district is a lack of teachers, and this kind of behavior does not seem likely to welcome many in. The teachers who are working with my kids are doing a commendable job in a very difficult situation (I marveled last week as my fourthgrader's teacher acted as an IT specialist as she coached nine-year olds to correct their blurry screens). I place tremendous currency on academics, but I understand there are many other lessons life has to offer us. Right now, the use of empathy and understanding in trying times is a lesson I hope my kids will learn during this pandemic, but I'm not sure that lesson was well modeled by DPS administration in this case.

And now I am stunned by the decision to offer a \$30,000 bonus to an administrator during this pandemic. On a global level, a bonus like this makes no sense to me. There will certainly be financial ramifications from the pandemic that will need to be prepared for—even in a district that isn't undergoing vast building projects. As a frontline health care worker, I feel I have gone above and beyond this year to do my job during changing, difficult, and stressful conditions. Although I could probably make the argument that I deserve a bonus for the work I have done, I understand none will be forthcoming because the future financial health of all business are tenuous right now; I can only hope that this board will arrive at the same conclusion.

The administrator's contract is stated to be performance based, linked to "student performance and academic improvement of the district." As stated these include "a. foster academic achievement among all learners," "b. establish a collaborative culture districtwide that improves the climate for learning in all schools," and "c. align organizational structure and resources to improve efficiency, effectiveness, and the financial health of the school district." How are these being met? Have academic achievement goals been met? Are students passing? Are they even logging on? Teacher morale is low, and teaching vacancies remain; is this an ideal culture for learning? Will this bonus serve the financial interests of the district?

My name is Sue Smeltzer. I attended Decatur schools, taught in both Decatur and Macon-Piatt Special Education Districts and am now a retired, tax-paying citizen of this city. As such, I have this to say:

It is my understanding that this correspondence won't be read until all business of the Board has been concluded. I still feel it's important that you know the level of distrust and distaste you have created throughout this community, specifically in relation to tax money being given as a performance bonus to Assistant Superintendent for Teaching and Learning, Jeffrey Dase.

We deserve better accountability than your recent decisions have provided. Our Strategic Plan Mission states it is the ultimate goal to create learning experiences "distinguished by … a culture of diversity, adaptability and resilience; meaningful and lasting relationships; extraordinary school and community connections." Those goals can only be attained if they are applied to every employee in the District as well as to students. You are failing to meet even the bare minimum standards for these goals when the efforts of classroom teachers to provide the finest available instruction and guidance are undermined by an administrator to whom you have now chosen to give a bonus equal to approximately 20% of his annual salary. You are sending the message that it is permissible to create division and unrest by blaming others; that in trying times resilience means attacking those on the front lines of making necessary adaptations; that meaningful and lasting relationships with teachers aren't a priority.

You are not only failing our teachers. You have failed and continue to fail all of those who care about the future of District 61. We cannot be a destination district when teachers are leaving and new teachers are refusing to come here. Teaching in itself is a small community. It is well known throughout the state, including the Schools of Education at our colleges and universities, that teachers are not valued in Decatur. The vacancies you haven't been able to fill over the last several years will be minor to what is coming.

Also from the District website, among the Board of Education Core Values is "Collaborate". As a Board and as an administration, you need to put that Core Value into practice in meaningful and easily observable ways.

Good evening DPS School Board

My name is Susan Vail and I have a daughter attending MacArthur H.S. as a junior. I am here representing myself, my daughter, and the parents/players of the MacArthur Girls B-ball team. We are very concerned about our daughters and their future. I understand that these are presidential times and that the Covid numbers are higher but those numbers do NOT represent kids attending in person learning or sports. DPS students are NOT contributing to spreading the virus due to being in school cause they are NOT. We were under the impression that online learning was temporary till a plan could be implemented. I know of several schools that have found a way to make it work – but we have NOT been given any options. We feel we need to take steps to live with this pandemic. We understand the online learning has it's place but it can NOT be the ongoing answer and our continued learning path. The kids need to be back in the classroom, back on the court, and they need their teachers and peers. We go to work every day as parents –we go to Wal-Mart –

Grandparents goes to Wal-Mart and still continue to see their grandchildren....so unless we all stop working, stop shopping, stop having any interactions with other humans is "possibly" the only way to stop Covid. DPS can't control what families do every day, so give us a choice with our children's learning plans.

I worry at night, my personal thoughts are, is my daughter getting enough from academics that she is not behind her peers to go to college. Is online learning giving her the same experience in Honors Human Anatomy with no labs? She struggles in Algebra 2 class and we argue about her grades – she says she needs one on one with the teacher. Is this going to affect her ACT score. Is she socially learning all the experiences to shape her into an adult. No Homecoming, no extracurricular clubs, will there even be school pictures, prom, graduation, senior nights, yearbook, etc. I haven't mentioned the emotional turmoil this has caused. The anxiety of not knowing and the lack of communication. Will or will not be allowed to play in a sport or even just practice. No options or an alternate plan. If MacArthur is NOT going to allow sports then please discuss with IHSA what alternatives we as parents can give our kids. Like I mentioned other schools are successful is participating in sports. I can go on an on and yes, these things keep us up at night.

We are financially paying full price for them to attend school but they are not attending in person – and I personally have increased our internet to a higher speed, hot spot(in case the internet goes down which it has), a gym membership (so she can continue to try to stay in shape) and a trainer (to keep her skills so IF she does see a court she won't be behind). I have her in therapy to deal with all this anxiety, and not to mention the loss of her HS coach. All these things mentioned are things she should be getting from her school.

We understand there may be sacrifices and we know you can do better. Give us options to return in in person learning and play the sport they love. Some suggestions to make alternate plans:

- Varsity only team limit the number of players
- Offer in person learning and online let us parents choose
- Continue with online but allow sports start off with just the athletes
- Weight lifting let them use the facilities sign up online 10/hour to come in and lift
- Gym time same as weight lifting limit the numbers
- Offer Science and Math classes to be in person learning in afternoon or give some other option

If you don't think this is having an impact on our daughters you are sadly mistaken. The stress and anxiety of NO school interactions is devastating and it is only going to get worse. We need a plan or options.

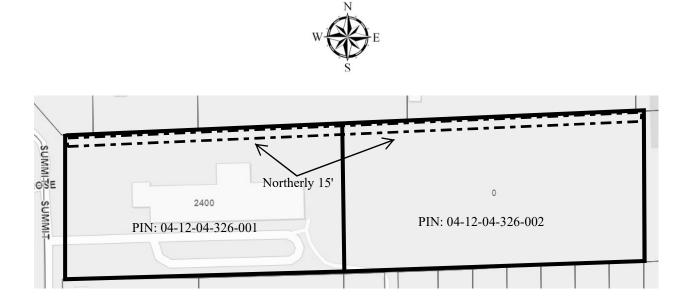

TERMS AND CONDITIONS

Performance of Services: The Architect shall perform the services outlined in this Agreement in consideration of the stated fee and payment terms.

Standard of Care: Services provided by the Architect under this Agreement will be performed in a manner consistent with that degree of care and skill ordinarily exercised by members of the same profession currently practicing under similar circumstances.

Additional Services: For additional services not included above, the Architect shall be compensated as follows: On an hourly rate basis in accordance with the Architect's Schedule of Standard Hourly Rates, unless mutually agreed otherwise.

Access to Site: Unless otherwise stated, the Architect will have access to the site for activities necessary for the performance of the services. The Architect will take reasonable precautions to minimize damage due to these activities, but has not included in the fee the cost for restoration of any resulting damage and will not be responsible for such costs.

Billing/Payment: The Client agrees to pay the Architect for all services performed and all costs incurred. Invoices for the Architect's services shall be submitted, at the Architect's option, either upon completion of such services or on a monthly basis. Invoices shall be due and payable upon receipt. If any invoice is not paid within 30 days, the Architect may, without waiving any claim or right against the Client, and without liability whatsoever to the Client, suspend or terminate the performance of services. Payment of invoices is in no case subject to unilateral discounting or set-offs by the Client, and payment is due regardless of suspension or termination of this Agreement by either party. Accounts unpaid 60 days after the invoice date may be subject to a monthly service charge of 1.5% (or the maximum legal rate) on the unpaid balance. In the event any portion of an account remains unpaid 120 days after the billing, the Architect may institute collection action and the Client shall pay all costs of collection, including reasonable attorney's fees.

Reimbursable Expenses: Reimbursable expenses are in addition to compensation for Basic and Additional Services and include expenses incurred by the Architect and its employees and consultants directly related to the Project. Reimbursable expenses shall be billed at one and one-tenth (1.10) times the amount invoiced to the Architect.

Indemnification: The Client shall, to the fullest extent permitted by law, indemnify and hold harmless the Architect, its officers, directors, employees, agents and consultants from and against all damage, liability and cost, including reasonable attorneys' fees and defense costs, arising out of or in any way connected with the performance of the services under this Agreement, excepting only those damages, liabilities or costs attributable to the sole negligence or willful misconduct of the Architect.

Waiver: In addition, the Client agrees, to the maximum extent permitted by law, to waive any claims against the Architect arising out of the performance of these services, except for the sole negligence or willful misconduct of the Architect.

Information for the Sole Use and Benefit of the Client: All options and conclusions of the Architect, whether written or oral, and any plans, specifications or other documents and services provided by the Architect are for the sole use and benefit of the Client and are not to be provided to any other person or entity without the prior written consent of the Architect. Nothing contained in this Agreement shall create a contractual relationship with or a cause of action in favor of any third party against either the Architect or the Client. All reports, plans, specifications, computer files, field data, notes and other documents and instruments prepared by the Architect as instruments of service shall remain the property of the Architect. The Architect shall retain all common law, statutory and other reserved rights, including the copyright thereto.

Certifications, Guarantees and Warranties: The Architect shall not be required to execute any document that would result in the Architect certifying, guaranteeing or warranting the existence of any conditions.



Limitation of Liability: In recognition of the relative risks, rewards and benefits of the project to both the Client and the Architect, the risks have been allocated such that the Client agrees that, to the fullest extent permitted by law, the Architect's total liability to the Client for any and all injuries, damages, claims, losses, expenses or claim expenses arising out of this Agreement from any cause or causes, shall not exceed the fee received. Such causes included, but are not limited to, the Architect's negligence, errors, omissions, strict liability, breach of contract or breach of warranty.

Dispute Resolution: Any claims or disputes between the Client and the Architect arising out to the services to be provided by the Architect or out of this Agreement shall be submitted to non-binding mediation. The Client and the Architect agree to include a similar mediation agreement with all contractors, subconsultants, subcontractors, suppliers and fabricators, providing for mediation as the primary method of dispute resolution among all parties. The laws of the State of Illinois will govern the validity of this Agreement, its interpretation and performance. Any litigation arising in any way from this Agreement shall be brought in the courts of that State.

Termination of Services: This Agreement may be terminated at any time by either party should the other party fail to perform its obligations hereunder. In the event of termination for any reason whatsoever, the Client shall pay the Architect for all services rendered to the date of termination, and all reimbursable expenses incurred prior to termination and reasonable termination expenses incurred as the result of termination.

Assignment: Neither party to this Agreement shall transfer, sublet or assign any rights under or interest in this Agreement (including, but not limited to, monies that are due or monies that may be due) without the prior written consent of the other party.
