BACKGROUND INFORMATION:

The attached reports illustrate the District's year-to-date revenue and expenditures and explain the financial condition of the Decatur School District, Macon-Piatt Special Education District, and the Decatur Area Technical Academy.

CURRENT CONSIDERATIONS:

We have made a few changes in the format of the District's monthly financial condition report to provide additional information from the budget and actual financial activities. The changes are as follows:

- --Fund Balance Summary: 1.) ARRA (Federal Stimulus) funds are listed separately below each of the corresponding funds (Education, Operations and Maintenance, and IMRF/Social Security). 2.) 'Fund Balance Proposed 6/30/2010' is now referenced on this report rather than the budget that was adopted last September.
- --District Financial Condition Report: 1.) ARRA (Federal Stimulus) funds are listed separately below each of the corresponding funds (Education, Operations and Maintenance, and IMRF/Social Security) in both the 'Revenues' and 'Expenditures' sections. 2.) The 'Percent Received/Used to Proposed Budget' is calculated on actual year-to-date as a percentage of the 'Proposed Budget'. 3.) 'Net Cash' includes total revenues and expenditures for all funds. The 'Proposed Budget' column was added to this month's report. 4.) ARRA (Federal Stimulus) are once again listed separately in the 'Fund Balances' section of the report.

The formats for the Financial Condition reports for Macon-Piatt Special Education District and Decatur Area Technical Academy have not changed.
